A complete set of Bidding Documents may be purchased from the Tarakeshwor Municipality, Municipal Executive Office, Dharmasthali, Kathmandu, by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Rs. 3000** till a period of **30 (Thirty) days** after publish date.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. 4. Pre-bid meeting shall be held at **Tarakeshwor Municipality, Municipal Executive Office** at **2:00 PM on 2074/09/09**
5. Sealed or electronic bids must be submitted to the Tarakeshwor Municipality, Municipal Executive Office, Dharmasthali-Kathmandu by hand/courier or through PPMO website www.bolpatra.gov.np/egp. on or before **12:00 Noon**. Bids received after this deadline will be rejected.
6. The Technical bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 31st day after publish date** at the Tarakeshwor Municipality, Municipal Executive Office, Dharmasthali. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 4,35,000.00/-** which shall be valid for 30 days beyond the validity period of the bid.
